**RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of January 3, 2014, is made by UBS AG, Stamford Branch, as First Lien Collateral Agent (“Lender”), in favor of Keystone Automotive Distributors Company, LLC, A&A Auto Parts Stores, Inc., Keystone Automotive Operations, Inc., and Arrow Speed Acquisition LLC (collectively, the “Company”) as follows:

WHEREAS, Lender acknowledges full payment, complete performance and satisfaction of all obligations pursuant to the Security Agreement have been made;

WHEREAS, Company has requested that Lender release its security interest in and to the Trademark Collateral, including without limitation the trademarks and all applications and registrations therefor set forth in Schedule A attached hereto and incorporated herein by reference.

NOW, THEREFORE, Lender, without recourse, representation or warranty and at Company’s sole cost and expense, hereby RELEASES all of its right, title and interest in and to the security interest granted to Lender in the Trademark Collateral, including without limitation the trademarks set forth in Schedule A.

LENDER agrees to provide Company with any information and additional authorization necessary to effect the release of Lender’s security interest in the Trademark Collateral at Company’s sole cost and expense.
