**RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "Release"), dated as of January 2, 2014, is made by BANK OF AMERICA, N.A., as Administrative Agent ("Agent"), under the Amended and Restated ABL Guarantee and Security Agreement referred to below. Terms used in this Release and not herein defined shall have the meanings set forth in the Security Agreement.

WHEREAS, in connection with that certain Amended and Restated ABL Guarantee and Security Agreement, dated as of August 15, 2013 (as amended, restated, supplemented or otherwise modified from time to time, the "Guaranty and Security Agreement"), among Keystone Automotive Operations, Inc. (the "Borrower"), Keystone Automotive Operations Midwest, LLC (f/k/a Keystone Automotive Operations Midwest, Inc.), the Guarantors party thereto (collectively, with the Borrower, the "Credit Parties") and Agent, and pursuant to those certain Intellectual Property Security Agreements described on Annex I attached hereto (collectively, the "Security Agreements"), the Credit Parties granted security interests in certain intellectual property owned by the Credit Parties and listed on Annex I attached hereto (collectively, the "Intellectual Property Collateral"); and

WHEREAS, the Security Agreements were recorded in the United States Patent and Trademark Office (the "USPTO") or the United States Copyright Office, as applicable, on the dates and on the reels, and frames or document numbers as set forth on Annex I hereto;


NOW THEREFORE, Agent hereby RELEASES, without representation, recourse or warranty whatsoever, all of its security interest in the Intellectual Property Collateral, whether granted pursuant to the Security Agreements or any other agreement or document delivered in connection with the Guaranty and Security Agreement, and Agent hereby reassigns any and all such right, title and interest (if any) that Agent may have in the Intellectual Property Collateral to the applicable Credit Party.
