RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, the Pledgor has requested that Secured Party release and reassign its interests in the trademarks more fully identified on Schedule 1;


NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged:

(2) The Secured Party agrees that, upon the request of the Pledgor or any successor in interest or assignee thereof, and at the expense of the Pledgor, the Agent shall execute any document, cause to be made any filing or take any other action deemed reasonably necessary or advisable by the Pledgor, or any successor in interest or assignee thereof, to effectuate the release of interests contemplated herein.
