Pursuant to the provision of Section 524.1501 of the Code of Iowa, City State Bank (the "Bank"), a state bank formed and existing under the Iowa Banking Act, adopts the following Articles of Amendment to the Restated Articles of Incorporation of the Bank:

- 1. The name of the Bank is: City State Bank.
- 2. The location of the Bank's principal place of business is: Central City, Linn County, Iowa.

3. The Bank adopted the following amendment to its Restated Articles of Incorporation:

(a.) Article I of the Restated Articles of Incorporation is hereby amended by deleting the following sentence, which is all of Article I:

"The name of the state bank shall be City State Bank."

and substituting in lieu thereof the following new sentence:

"The name of the state bank shall be NXT Bank."

4. The amendment to the Restated Articles of Incorporation of the Bank was approved by the shareholder of the Bank on August 13, 2013 by unanimous written Consent Action, in which the shareholder waived all required notices.

5. The designation, number of outstanding shares, number of votes entitled to be cast by each voting group or class entitled to vote separately on the amendment, and the number of votes of each voting group or class indisputably represented at the meeting or acting by written consent is as follows:

The number of votes voting or acting by written consent for the amendment was sufficient for approval of the amendment by the shareholder.

5. This Amendment shall be effective as of October 1, 2013.
