WHEREAS, ASSIGNEE, confirms that it accepted the entire right, title and interest in the Marks and the goodwill associated with the Marks on October 12, 2012.

NOW, THEREFORE, in consideration of the mutual covenants and agreements hereinafter set forth, and other good and valuable consideration, the receipt and sufficiency of which being hereby acknowledged, ASSIGNOR hereby confirms the conveyance, transfer, assignment, and deliverance to ASSIGNEE, as of October 12, 2012, all of ASSIGNOR'S right, title, and interest in and to the Marks and the Property, together with (1) the goodwill of the business relating to the Products in respect upon which the Marks are used and for which they are registered: (2) all income, royalties, and damages hereafter

due or payable to ASSIGNOR with respect to the Marks, including without limitation, damages, and payments for past infringements and misappropriations of the Marks; and (3) all rights to sue for past, present and future infringements or misappropriations of the Marks.

ASSIGNOR further covenants that it will execute all documents, papers, forms and authorizations and take all other actions that may be necessary for securing, completing, or vesting in ASSIGNEE full right, title, and interest in the Marks and the Property.


