TRADEMARK SECURITY AGREEMENT

This **TRADEMARK SECURITY AGREEMENT**, dated as of November 15, 2013 (as the same may hereafter be amended, restated, or otherwise modified from time to time, this "Agreement"), is made and entered into by and among **CRESTCOM INTERNATIONAL HOLDINGS, LLC**, a Delaware limited liability company ("Holdings"), and **CRESTCOM INTERNATIONAL, LLC**, a Delaware limited liability company ("OpCo" and, together with Holdings, "Borrower"), in favor of **GUARANTY BANK AND TRUST COMPANY**, a Colorado corporation (together with its participants, successors and assigns, the "Secured Party").

WITNESSETH:

WHEREAS, pursuant to the Loan and Security Agreement, dated of even date herewith (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Loan Agreement"), between Borrower and the Secured Party, the Secured Party has agreed to make extensions of credit to Borrower upon the terms and subject to the conditions set forth therein;

WHEREAS, Borrower has agreed, pursuant to the Loan Agreement, to grant a security interest in all of Borrower's assets to the Secured Party, including but not limited to Borrower's General Intangibles (as defined therein), and in connection therewith the parties hereto desire to enter into this Agreement;

NOW, THEREFORE, in consideration of the premises and to induce the Secured Party to enter into the Loan Agreement and to make extensions of credit to Borrower thereunder, Borrower hereby agrees with the Secured Party as follows:

Section 1. Defined Terms. Capitalized terms used herein without definition are used as defined in the Loan Agreement.

Section 2. Grant of Security Interest. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, to secure the prompt and complete payment in full and performance when due of all of the Obligations, Borrower does hereby mortgage, pledge and hypothecate to the Secured Party, and grant to the Secured Party a security interest in, all of the following property of Borrower (the "Trademark Collateral"), whether now owned or hereafter acquired or existing:

(a) all of Borrower's trademarks, service marks, trade names, trade dress or other indicia of trade origin, trademark and service mark registrations, and applications for trademark or service mark registrations, and any renewals thereof, including, without limitation, each registration and application identified on **Schedule 1.1** attached hereto and made a part hereof, and including without limitation (i) the right to sue or otherwise recover for any and all past, present and future infringements and misappropriations thereof, (ii) all income, royalties, damages and other payments now and hereafter due and/or payable with respect thereto (including, without limitation, payments under all trademark licenses entered into in connection therewith, and damages and payments for past or future infringements thereof) and (ii) all rights corresponding thereto and all other rights of any kind whatsoever of Borrower accruing

thereunder or pertaining thereto, together in each case with the goodwill of the business connected with the use of, and symbolized by, each such trademark, service mark, trade name, trade dress or other indicia of trade origin;

(b) all license agreements with any other Person in connection with any of Borrower's trademarks or such other Person's names or trademarks, whether Borrower is a licensor or a licensee under any such license agreement, including, without limitation, the license agreements listed on **Schedule 1.1** attached hereto and made a part hereof, subject, in each case, to the terms of such license agreements, and the right to prepare for sale, and to sell and advertise for sale, all inventory now or hereafter covered by such licenses;

(c) all renewals of any of any of the items described in subsections (a) through (b) above;

(d) all of Borrower's goodwill connected with the use of, and symbolized by each of the items described in subsections (a) through (c) above;

(e) all proceeds of, and rights associated with, the foregoing, including any of Borrower's right to sue or claim against third parties for past, present, or future infringement or dilution of any of the Trademark Collateral referred to in **Schedule 1.1** attached hereto, or for any injury to the goodwill associated with the use thereof or for breach or enforcement of any trademark license.

Section 3. Loan Agreement. This Agreement has been executed and delivered by Borrower for the purpose of registering the security interest of the Secured Party in the Trademark Collateral with the United States Patent and Trademark Office. The security interest granted hereby has been granted as a supplement to, and not in limitation of, the security interest granted to the Secured Party under the Loan Agreement as security for the payment in full and performance of the Obligations and Borrower hereby acknowledges and agrees that the rights and remedies of the Secured Party with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Loan Agreement, the terms and provisions of which (including the remedies provided for therein) are incorporated by reference herein as if fully set forth herein.

Section 4. Borrower Remains Liable. Borrower hereby agrees that, anything herein to the contrary notwithstanding, Borrower shall assume full and complete responsibility for the prosecution, defense, enforcement or any other necessary or desirable actions in connection with the Trademark Collateral subject to a security interest hereunder.

Section 5. Borrower. This Agreement has been executed by multiple parties who are referred to in this Agreement individually, collectively and interchangeably as "Borrower." Unless specifically stated to the contrary, the word "Borrower," when used in this Agreement, including without limitation all representations, warranties and covenants, shall include all Borrowers and any breach of any representation, warranty or covenant by one Borrower shall apply to all Borrowers.

Section 5. Counterparts. This Agreement may be executed in any number of counterparts and by different parties in separate counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Signature pages may be detached from multiple separate counterparts and attached to a single counterpart.


