## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of this 3<sup>rd</sup> day of January, 2014, is entered into by and between Nature America, Inc., a New York corporation, having an address of 75 Varick Street, 9th Floor, New York, NY 10013-1917 ("Secured Party"), and Relay Technology Management, Inc., a Massachusetts corporation, having an address of 25 First Street, Suite 104, Cambridge, MA 02141 ("Grantor").

WHEREAS, pursuant to the terms and conditions of that certain Note Purchase and Security Agreement by and between Grantor and Secured Party dated February 11, 2013 (the "Security Agreement"), Grantor granted to and in favor of Secured Party a security interest in and to all of Grantor's right, title and interest in, to and under the trademarks, and registrations of and applications to register the foregoing, owned by the Grantor, including, without limitation, the trademarks listed on Schedule A attached hereto (collectively, the "Trademarks"), in each case, together with the proceeds of any and all of the foregoing;

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on February 13, 2013, at Reel 4962, Frame 0431; and

WHEREAS, Grantor has paid all of its outstanding indebtedness to Secured Party.

NOW, THEREFORE, for good and valuable consideration, the receipt, sufficiency and adequacy of which are hereby acknowledged, the parties hereto agree as follows:

Secured Party hereby terminates the Security Agreement, and hereby absolutely and unconditionally terminates, cancels, discharges and releases any and all security interests it has against the Trademarks.


Secured Party shall take all further actions, and provide to Grantor, Grantor's successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Grantor to more fully and effectively effectuate the purposes of this Release.

Secured Party expressly acknowledges and affirms that upon execution hereof, it shall have no rights and remedies with respect to the Trademarks.
