**ASSIGNMENT OF TRADEMARKS**

**THIS ASSIGNMENT** is made this 7<sup>th</sup> day of January, 2014, by and between the Chamber of Commerce of the United States of America, a District of Columbia corporation with an address of 1615 H Street, N.W., Washington, D.C. 20062 (the "Assignor") on the one hand, and the The Madison County Record, Inc., an Illinois corporation located at 301 North Main Street, Edwardsville, IL (the "Assignee") on the other hand.

**WHEREAS**, the Assignor wishes to sell and assign, and Assignee wishes to purchase and assume, the Trademarks;


**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby severally acknowledged, the parties hereto agree as follows:

1. Assignor hereby assigns to Assignee all right, title and interest in, to, and under the Trademarks, including all registrations and applications therefor, together with the goodwill associated therewith.
2. The Assignor further grants to Assignee the right to recover damages and all other relief for all infringements of the Trademarks that have occurred prior to the date of this Assignment with the right to sue for and collect the same, for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives, free and clear of all liens, claims, charges, security interests, and other encumbrances.
3. The parties acknowledge and agree that this assignment is to confirm the rights of the parties as they have been since November 15, 2006.
