NUNC PRO TUNC DEED OF ASSIGNMENT

Clariant International Ltd (“ASSIGNOR”), a Swiss corporation with a principal place of business at Rothausstraße 61, 4132 Muttenz, Switzerland, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, does hereby assign, sell and transfer, *nunc pro tunc*, effective January 1, 2013, to Clariant AG, (“ASSIGNEE”), a corporation organized under the laws of Switzerland with a principal place of business at Rothausstraße 61, 4132 Muttenz, Switzerland, the entire right, title and interest in and to the trademarks listed in the table below, and the registration and applications for registration thereof that are specified below, including renewal rights therein, together with the goodwill symbolized by such marks as well as all rights in and to any and all claims ASSIGNOR may have, at law or in equity for past infringement thereof, the same to be held and enjoyed by ASSIGNEE as fully and entirely as the same would have been held by ASSIGNOR had this transfer, assignment and sale not been made.
