


Pursuant to Section 252 of the General  
Corporation Law of Delaware

Orograin Bakeries Sales, Inc., a Delaware corporation ("Terminating Corporation"), and Orograin Bakeries Manufacturing, Inc., a New York corporation ("Surviving Corporation") do hereby certify to the following facts relating to the merger ("Merger") of the Terminating Corporation with and into the Surviving Corporation.


1. The names and states of incorporation of the constituent corporations of the Merger are Orograin Bakeries Sales, Inc., which is incorporated pursuant to the General Corporation Law of the State of Delaware ("DGCL"), and Orograin Bakeries Manufacturing, Inc., which is incorporated pursuant to the Business Corporation Law of the State of New York ("NYBCL").
2. That an Agreement and Plan of Merger ("Agreement") between the parties to the Merger has been approved, adopted, certified, executed and acknowledged by the Surviving Corporation and the Terminating Corporation in accordance with the requirements of Section 252 of the DGCL.
3. The name of the Surviving Corporation shall be Orograin Bakeries Manufacturing, Inc.
4. That the Certificate of Incorporation of the Surviving Corporation shall continue in full force and effect as its Certificate of Incorporation.
5. The effective time of the merger is 11:59 p.m. EST on December 30, 2013.
6. That the executed Agreement is on file at the principal place of business of the Surviving Corporation, the address of which is 255 Business Center Drive, Horsham, Pennsylvania 19044.
7. A copy of the Agreement will be furnished by the Surviving Corporation, on request and without cost, to any stockholder of the Surviving Corporation or Terminating Corporation.
8. The Surviving Corporation agrees that it may be served with process in the State of Delaware in any proceeding for enforcement of any obligation of the Surviving Corporation arising from this Merger, including any suit or other proceeding to enforce the rights of any stockholders as determined in appraisal proceedings pursuant to the provisions of Section 262 of the DGCL, and irrevocably appoints the Secretary of State of Delaware as its agent to accept services of process in any such suit or proceeding. The Secretary of State shall mail any such process to the Surviving Corporation at 255 Business Center Drive, Horsham, PA 19904.
