RELEASE OF TRADEMARK SECURITY INTEREST AGREEMENT

WHEREAS, Tippmann Sports, LLC ("Grantor") entered in that certain Confirmatory Grant of Trademark Security Interest dated August 14, 2006 ("Security Agreement") in favor of Golub Capital Incorporated in its capacity as agent for certain lenders ("Secured Party"), which Agreement was recorded with the United States Patent and Trademark Office on September 8, 2006 under reel/frame no. 003387/0363;

WHEREAS, the Secured Party desires now to (i) release its security interest in Grantor's Trademarks; (ii) waive all of its right, title and interest in and to Grantor's Trademarks and restore all such right, title and interest in and to Grantor's Trademarks to Grantor; and (iii) dissolve any and all liens and encumbrances respecting Grantor's Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party does hereby release its security interest in Grantor's Trademarks, and discharges, quit claims and relinquishes to Grantor, any and all right, title and interest it has in and to Grantor's Trademarks referenced on Schedule A;


