

CERTIFICATE OF OWNERSHIP AND MERGER

Pursuant to Section 253 of the General Corporation Law of the State of Delaware (the "DGCL"), Green Mountain Coffee Roasters, Inc., a Delaware corporation (the "Company"), hereby certifies as follows:

FIRST: The Company was organized pursuant to the provisions of the DGCL on the 20th day of July, 1993, under the name of "Green Mountain Coffee, Inc.", and the Company merged with Green Mountain Coffee Roasters, Inc. on the 31st day of December, 2002 to become "Green Mountain Coffee Roasters, Inc.";

SECOND: The Company is the legal and beneficial owner of all of the outstanding shares of the capital stock of Keurig, Incorporated ("Keurig"), a corporation organized pursuant to the provisions of the DGCL on the 25th day of February, 1998;

THIRD: On December 5, 2013, the Board of Directors of the Company determined to merge Keurig with and into the Company, with the Company continuing as the surviving corporation (the "Merger"), and adopted the following resolutions by unanimous written consent in lieu of a special meeting:

"RESOLVED: That the Company is authorized to cause Keurig, Incorporated, a Delaware corporation and a direct, wholly-owned subsidiary of the Company ("Keurig"), to be merged with and into the Company in accordance with the terms and conditions set forth in the following resolutions, with the Company continuing as the surviving corporation (the "Merger"); and further

RESOLVED: That, upon the Merger becoming effective, all obligations of Keurig automatically will be assumed by the Corporation, and all estate, property, rights, privileges, powers and franchises of Keurig automatically will be vested in, and held and enjoyed by, the Company, as fully and entirely, without change or diminution, as the same were before held and enjoyed by Keurig in its name; and further

RESOLVED: That, upon the Merger becoming effective, all shares of the outstanding capital stock of Keurig will be surrendered and cancelled, and the sole holder of the outstanding capital stock of Keurig will cease to have any rights with respect to such capital stock; and further

RESOLVED: That the certificate of incorporation of the Company will be the certificate of incorporation of the surviving corporation, to continue unchanged and in full force and effect until thereafter altered or amended as provided therein or by applicable law; and further


RESOLVED: That the Merger will be effective on December 31, 2013 at 11:59 p.m. Eastern Time following the filing with the Delaware Secretary of State of a Certificate of Ownership and Merger in substantially the form attached hereto as Exhibit A."

FOURTH: The Certificate of Ownership and Merger and the Merger shall become effective on December 31, 2013 at 11:59 p.m. Eastern Time.
