ASSIGNMENT OF TRADEMARKS

This ASSIGNMENT OF TRADEMARKS (this "Assignment") is entered into on this 1st day of April, 2012 (the "Effective Date"), between Illinois Tool Works, Inc., a Delaware corporation (the "Assignor"), and ITW Gema GmbH., a *Gesellschaft mit beschränkter Haftung*, duly incorporated and validly existing under the laws of the Swiss Confederation ("Assignee"). This Assignment being entered into on the Effective Date pursuant to the transactions contemplated by that certain Asset Purchase Agreement made and entered into as of April 14, 2011, by and among Graco Inc., a Minnesota corporation, Graco Holdings Inc., a Minnesota corporation, Graco Minnesota Inc., a Minnesota corporation, **Assignor**, and ITW Finishing LLC, a Delaware limited liability company (as amended, the "Purchase Agreement"). Capitalized terms not defined herein will have the meaning set forth in the Purchase Agreement.

RECITALS

WHEREAS, Assignor is the owner of the entire right, title and interest in and to the trademarks and trademark applications set forth in Appendix A (collectively, the "Trademarks"), and Assignee wants to acquire the entire right, title and interest in and to the aforesaid Trademarks.

AGREEMENT

THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Transferor does hereby assign, transfer and convey to Transferee its entire right, title and interest in and to said Trademarks, including the trademark registrations, trademark applications and common law rights therein, and all benefits, privileges, causes of action, claims and remedies arising out of or relating to the Trademarks, and all of the goodwill associated with any of the foregoing.

This Assignment shall be construed, interpreted and applied in accordance with the laws of the State of Delaware.

This Assignment may be amended or modified only by a written instrument signed by each Party.

This Assignment may be executed in one or more counterparts, all of which shall be considered one and the same agreement, and subject to the Closing under the Purchase Agreement and shall become effective when one or more such counterparts have been signed by each of the Parties and delivered to the other Party.




