ACCOUNT PSG TERMINATION AND RELEASE

Whereas Export Development Canada ("EDC") issued Account Performance Security Guarantee No. 48209 to Royal Bank of Canada, as Administrative Agent (the "Bank") on behalf of Allen-Vanguard Corporation (as amended to the date hereof, the "Account PSG").

Whereas all outstanding Bank Instruments and Bank Instructions covered by EDC under the Account PSG have expired and EDC and the Bank now wish to terminate the Account PSG.


NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, receipt and adequacy of which are hereby acknowledged, EDC and the Bank hereby agree as follows:


- (i) The Account PSG is unconditionally and irrevocably terminated in its entirety and has no further force or effect.
- (ii) The Bank, its officers, directors, shareholders, successors and assigns do hereby release and forever discharge EDC, and its officers, directors, shareholders, reinsurers, successors and assigns, from any and all claims, demands, obligations, actions, causes of action, suits, charges, covenants, agreements, contracts and liabilities whatsoever, both in law and in equity, or by statute, known or unknown, whether implied or expressed, which the Bank now has, ever had or may have hereinafter in connection with the Account PSG, including any and all damages and losses known and unknown or anticipated.
- (iii) The effective date of this Termination and Release is March 20, 2013, and the Bank and EDC waive the notice period contained Section 13(1) of the Account PSG.
- (iv) This Termination and Release shall be governed by and construed in accordance with the laws of the Province of Ontario and the laws of Canada applicable therein.
- (v) This Termination and Release may be delivered by facsimile or by electronic mail and receipt by facsimile or by electronic signature of an executed copy of this Termination and Release shall be deemed to be receipt of an original.


