RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office ("USPTO") on June 18, 2010 at Trademark Reel No. 4227, Frame No. 0595; and

WHEREAS, the Collateral Agent has agreed to release its security interest in all of the right, title, and interest of the Company in the Trademark Collateral, and to reconvey any and all right, title, or interest it may have in the Trademark Collateral to the Company;
