**SECOND ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF SYSTINO, INC.**

Pursuant to Section 14-2-1002 of the Georgia Business Corporation Code, Systino, Inc., a Georgia corporation (the "Corporation"), does hereby state, adopt and declare the following:

Article 1.

The name of the corporation is Systino, Inc.

Article 2.

The original Articles of Incorporation were filed with the Secretary of State of the Sate of Georgia on June 17, 2008. Articles of Amendment to the Articles of Incorporation were filed with the Secretary of State of the State of Georgia on March 6, 2009. The Articles of Incorporation, as amended by these Second Articles of Amendment, are referred to herein as the "Articles."

Article 3.

Article 1 of the Articles shall be amended to read as follows:

The name of the corporation is Listen360, Inc.

Article 4.

The Corporation hereby certifies that these Second Articles of Amendment to the Articles of Incorporation of the Corporation, as set forth in Article 3 above, were duly adopted by the Board of Directors of the Corporation on February 10, 2012 pursuant to the authority granted to the Board of Directors under Section 1002 of the Georgia Business Corporation Code without shareholder approval in that shareholder approval was not required.

Article 5.

Notice of the Corporation's change of corporate name along with payment thereof has been forwarded to the Fulton County Daily Report, the official organ of Fulton County where the registered office of the Corporation is located.
