**ARTICLES OF AMENDMENT
OF ARTICLES OF INCORPORATION
OF
THINLINE, INC.**

Pursuant to Section 55-10-06 of the General Statutes of North Carolina, the undersigned corporation hereby submits the following Articles of Amendment for the purpose of amending its Articles of Incorporation:

1. The name of the corporation is Thinline, Inc.
2. The text of the amendment adopted is as follows:


The Articles of Incorporation of the corporation are hereby amended to change the name of the corporation by deleting Article I in its entirety and inserting the following new Article I in lieu thereof:

“The name of the corporation is Thinline Holdings, Inc. (the “Corporation”).”

3. The foregoing amendment does not provide for an exchange, reclassification, or cancellation of issued shares.
4. The foregoing amendment was duly adopted by the shareholders of the corporation as required by Chapter 55 of the North Carolina General Statutes on August 1, 2007.
5. These articles will be effective upon filing.
