TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment") is made and entered into this 23rd day of December, 2013, by and between S A S Safety Corp., a California corporation ("Assignor"), which also filed trademark applications under the designations "S.A.S. Safety Corporation" and "SAS Safety Corporation," and SAS Safety Corporation, a Virginia corporation ("Assignee"). Each of Assignor and Assignee is sometimes referred to herein as a "Party," and together they are referred to as the "Parties."

RECITALS:

A. Assignor and Assignee are parties to that certain Asset Purchase Agreement, dated as of even date herewith (the "Purchase Agreement"), pursuant to which Assignee has agreed, among other things, to purchase certain assets of Assignor.

B. Assignor owns the rights, title and interest to the trademarks set forth in Exhibit A attached hereto (hereinafter such trademarks shall be referred to as the "Trademarks").

C. Pursuant to the Purchase Agreement, Assignor has agreed to assign to Assignee, and Assignee has agreed to assume, all right, title and interest of Assignor in and to the Trademarks.

AGREEMENT:

NOW, THEREFORE, in consideration of these premises, the mutual covenants and agreements herein contained, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereto agree as follows:

1. Assignment of the Trademarks. Assignor hereby assigns and transfers unto Assignee the entire right, title and interest of Assignor in and to the Trademarks and all registrations issuing therefrom, together with the goodwill associated therewith, and the right to sue for, and recover for, any past infringements thereof.

2. Further Assurances. Assignor shall (and shall cause any Person under its control to) execute, perform and deliver such additional documents, instruments, deeds, conveyances and assurances as may be reasonably requested by Assignee from time to time in order to carry out the provisions hereof and give effect to the transactions contemplated by this Assignment.

3. Conflict and Inconsistency. This Assignment is executed and delivered by Assignor pursuant to the Purchase Agreement, subject to the covenants, representations and warranties thereof. No provisions set forth herein shall be deemed to enlarge, alter or amend the terms or provisions of the Purchase Agreement. In the event of any conflict between the provisions herein and the Purchase Agreement, the provisions of the Purchase Agreement shall control.

4. Successors and Assigns. This Assignment shall be binding upon and shall inure to the benefit of the Parties hereto and their respective successors and permitted assigns.

5. Governing Law. This Assignment shall be governed by and construed and interpreted according to the internal laws of the State of California, without giving effect to any choice or conflict of law provision or rule (whether of the State of California or any other jurisdiction) that would cause the application of laws of any jurisdiction other than those of the State of California.

6. Miscellaneous. This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Assignment delivered by facsimile, e-mail or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Assignment.




