## TERMINATION AND RELEASE

December 19, 2013

1. Reference is made to the Security Agreement (the "**Security Agreement**") dated as of January 17, 2001, between Holsum de Puerto Rico, Inc. ("**Holsum**" or the "**Borrower**"), and FirstBank Puerto Rico ("**FBPR**"), as lender and as administrative agent (in such capacity, the "**Agent**") for the lenders (the "**Lenders**") parties to the Credit Agreement dated as of January 17, 2001, among the Borrower, certain other Loan Parties parties thereto, the Lenders and the Agent.
2. Pursuant to the Security Agreement, the Borrower granted to the Agent, for the benefit of the Lenders, a lien and security interest over the License Agreement (the "**License Agreement**") dated January 11, 1997 between the Borrower (f/k/a Holsum Bakers of Puerto Rico) and the W.E. Long Company – Independent Bakers' Cooperative ("**Long**"), as security for the Borrower's obligations under the Credit Agreement. Pursuant to the License Agreement, Long granted to the Borrower a license to use Long's registered trademark "**Holsum**", and certain related trademarks and packaging rights, including registered copyrights in the "**Holsum**" wrapper design and/or trade dress rights in bags and wrapper designs or other packaging for bakery products.
3. The lien and security interest over the License Agreement is recorded with the United States Patent and Trademark Office (the "**USPTO**") under Registration Numbers 1928775 and 1918002.
4. The Agent, for itself and on behalf of the Lenders, hereby: (a) acknowledges that all obligations of the Borrower and the other Loan Parties under the Credit Agreement have been paid, satisfied, and performed in full; (b) irrevocably and unconditionally terminates and releases the lien and security interest created by the Security Agreement over the License Agreement; and (c) irrevocably and unconditionally authorizes and directs the USPTO to cancel, of record, all liens and security interests in the Agent's favor over the License Agreement that appear recorded in the books of the USPTO, including, without limitation, those at Registration Numbers 1928775 and 1918002.
