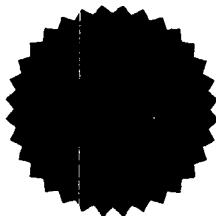

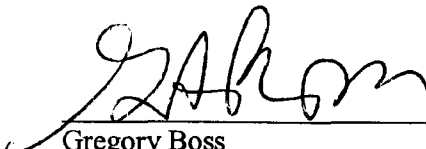
AVENTIS BEHRING L.L.C.

This Amended and Restated Certificate of Formation of AVENTIS BEHRING L.L.C., dated June 28, 2004, has been duly executed and is being filed by the undersigned, as an authorized person, in accordance with the provisions of 6 Del. C. § 18-208, to amend and restate the original Certificate of Formation of Aventis Behring L.L.C. (whose original name was "Verion L.L.C."), which was filed with the Secretary of State of the State of Delaware (the "Secretary of State") on May 15, 1995, as amended by the Certificate of Amendment, which was filed with the Secretary of State on July 13, 1995, as amended and restated by the Amended and Restated Certificate of Formation of Centeon L.L.C., which was filed with the Secretary of State on December 22, 1999 (as amended and restated, the "Certificate"), to form a limited liability company under the Delaware Limited Liability Company Act (6 Del. C. §18-101, et seq.).

The Certificate is hereby amended and restated in its entirety to read as follows:

1. Name. The name of the limited liability company is "ZLB Behring L.L.C." (the "Company").
2. Registered Office. The address of the registered office of the Company in the State of Delaware is The Corporation Trust Company, Corporation Trust Center, 1209 Orange Street, Wilmington, New Castle County, Delaware 19801.
3. Registered Agent. The name and address of the registered agent for service of process on the Company at such address is The Corporation Trust Company, Corporation Trust Center, 1209 Orange Street, Wilmington, New Castle County, Delaware 19801.
