## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks (this "**Release**") is dated as of January 14, 2014, and entered into by **MMV CAPITAL PARTNERS INC.**, as assignee of MMV Finance Inc. WHEREAS, the Security Interest was recorded with the United States Patent and Trademark Office on January 8, 2013, Reel/Frame 4938/0710; and

WHEREAS, Secured Party now desires to terminate and release its security interest in and lien on the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby terminates, releases, and discharges fully its security interest in and lien on the Trademark Collateral (including without limitation the trademarks listed on Schedule A hereto) as granted pursuant to the Security Interest, and Secured Party reconveys, transfers, and assigns to Grantor, as applicable, without recourse, representation or warranty of any kind, any rights it may have in the Trademark Collateral pursuant to or in connection with the Security Interest and any right, title or interest of Secured Party shall hereby cease and become void.
