**TERMINATION AND RELEASE OF SECURITY INTEREST IN CERTAIN
U.S. TRADEMARKS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN CERTAIN U.S. TRADEMARKS (the "*Trademark Termination and Release*") dated as of January 15, 2014, from BANK OF AMERICA, N.A., in its capacity as administrative agent (in such capacity, the "*Administrative Agent*"), pursuant to a Security Agreement (the "*Security Agreement*") dated as of August 27, 2013 among CECO Environmental Corp., a Delaware corporation (the "*Borrower*"), certain Subsidiaries of the Borrower, and the Administrative Agent.

WITNESSETH:

WHEREAS, pursuant to the Security Agreement a security interest (the "*Security Interest*") was granted by, among others, MPC Inc. (hereinafter referred to as the "*Grantor*") to the Administrative Agent in certain collateral, including the Specified Trademark Collateral (as hereinafter defined); and

WHEREAS, a Notice of Grant of Security Interest in Trademarks was recorded in the Trademark Division of the United States Patent and Trademark Office on August 27, 2013 at Reel 5098, Frame 0846; and

WHEREAS, the Administrative Agent has agreed to release its Security Interest in the Specified Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby agrees as follows:

1. Definitions. The term "*Specified Trademark Collateral*", as used herein, shall mean the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks and trademark applications described on Schedule I hereto.

2. Release of Security Interest. The Administrative Agent hereby terminates, releases and discharges its Security Interest in the Specified Trademark Collateral described on Schedule I hereto without representation, warranty or recourse of any kind or nature. Except for the foregoing release of the Security Interest in the Specified Trademark Collateral, no other lien or security interest on the Grantor's assets (including other trademarks and trademark applications) in favor of the Administrative Agent is released or terminated.

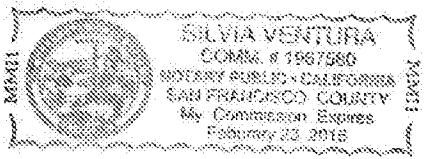

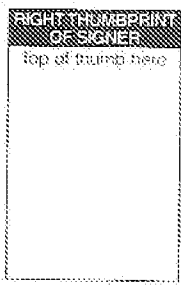

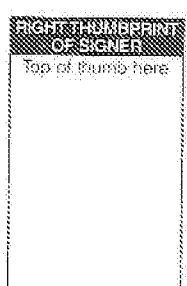
