Pursuant to Section 264(c) of the General Corporation Law of the State of Delaware (the "DGCL") and Section 18-209 of the Limited Liability Company Act, the undersigned limited liability company does hereby certify that:

FIRST: The name and state of formation of each of the constituent companies of the merger (the "Constituent Companies") is as follows:

SECOND: An Agreement and Plan of Merger dated as of December 13, 2013 by and among STG-Fairway US, Inc., a Delaware corporation ("STG-Fairway"), and STG-Fairway U.S. Restructure, LLC, a Delaware limited liability company ("SM"), has been approved, adopted, certified, executed and acknowledged by each of the Constituent Companies in accordance with the provisions of Section 264(c) of the DGCL and Section 18-209 of the Limited Liability Company Act.

THIRD: The surviving company shall be STG-Fairway U.S. Restructure, LLC (the "Surviving Company") and the name of the Surviving Company shall be changed to "STG-Fairway U.S., LLC."

FOURTH: That the Certificate of Formation of the Surviving Company shall be amended to change the name of the Surviving Company to "STG-Fairway U.S., LLC."

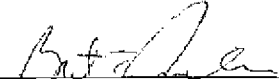
