**GRANT OF SECURITY INTEREST
(TRADEMARKS)**

THIS GRANT OF SECURITY INTEREST, dated December ^{18th}, 2013, is made by CC MARINE BRAND ACQUISITION, LLC, a Delaware limited liability company (the "Grantor"), in favor of USAMERIBANK, a Florida banking corporation (the "Grantee").

WHEREAS, Grantee, has made or will make certain loans to Grantor, Chris Craft Corporation, a Delaware corporation, Chris Craft Limited, a Jersey company, Chris Craft USA, Inc., a Delaware corporation, and CC Property Acquisition, LLC, a Delaware limited liability company in (i) the original principal amount of \$5,200,000.00, evidenced by a Promissory Note of even date herewith and (ii) the original principal amount of \$3,500,000, each evidenced by a Promissory Note of even date herewith (hereinafter, collectively, the "Loans") and the Loans are subject to the terms and conditions as set forth in that certain Loan Agreement dated as of the date hereof (as the same may be amended, restated, supplemented, or otherwise modified from time to time, the "Loan Agreement"; capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Loan Agreement);

WHEREAS, the Grantor owns certain trademarks (including service marks), trademark applications, trademark registrations and trade names now or hereafter acquired, including, but not limited those listed on Schedule 1 hereto, along with the goodwill appurtenant thereto, and any and all (i) renewals thereof, (ii) income, royalties, damages and payments now and hereafter due and/or payable with respect thereto, including, without limitation, damages and payments for past or future infringements thereof, (iii) rights to sue for past, present and future infringements thereof; and (iv) rights corresponding to all of the foregoing throughout the world, excluding for all purposes herein United States intent-to-use trademark applications to the extent that and solely during the period in which the grant of a security interest therein would impair the registrability of such applications or the validity of registrations issuing from such applications (all of the foregoing trademarks (including service marks, trade names, trade styles and trade dress), trademark applications, trademark registrations, trade names, fictitious names, service marks, together with the items described in the foregoing clauses (i) through (iv), are sometimes hereinafter individually and/or collectively referred to as the "Trademarks"); and

WHEREAS, it is a condition precedent to the effectiveness of the Loan Agreement that the Grantor shall have executed and delivered this Grant of Security Interest.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, as collateral security for the payment, performance and observance of all of the Obligations, the Grantor does hereby mortgage, pledge and grant to the Grantee a lien on and security interest in all of the Grantor's right, title and interest in, to and under the Trademarks, whether presently existing or hereafter arising or acquired.

The Grantor agrees that until the Obligations shall have been satisfied in full in cash and the Borrower's Loans with the Grantee including, and all commitments to lend thereunder, shall have been terminated, the Grantor will not, without the Grantee's prior written consent, which consent shall not be unreasonably withheld, license any Trademark, other than (i) licenses entered into in the ordinary course of business with unaffiliated third parties upon arms' length

terms and (ii) licenses with any other Borrower, which is inconsistent with the Grantor's obligations under this Grant of Security Interest and the Grantor further agrees that it will not take any action, or permit any action to be taken by others subject to its control, including licensees, or fail to take any action, which would reasonably be expected to affect the validity or enforceability of the Trademarks that are material to the operation of the business.

The Grantor represents and warrants that the Trademarks listed on Schedule 1 constitute all of the trademarks, and the registrations and applications therefor filed with the United States Patent and Trademark Office, the Canadian Patent Office, the UK Patent Office and/or the Office for Harmonization of the Internal Market (OHIM) for the European Community now owned by the Grantor. If, before the Obligations shall have been satisfied in full and the Loans shall have been terminated, the Grantor shall (i) obtain rights to any new Trademarks, the provisions of this Grant of Security Interest shall automatically apply thereto and the Grantor shall give to the Grantee prompt written notice thereof (with delivery of periodic reports). The Grantor hereby authorizes the Grantee to modify this Grant of Security Interest by amending Schedule 1 to include any future Trademarks and to record this Grant of Security Interest against any such applications and registrations of Trademarks.

The term of the security interest granted herein shall extend until the earlier of (i) the expiration of each of the respective Trademarks assigned hereunder, or (ii) the Obligations have been paid in full and the Loans have been terminated.

The Grantor shall have the duty (i) to prosecute diligently any trademark application of the Trademarks that is material to the use and operation of the business pending as of the date hereof or thereafter until the Obligations shall have been paid in full and the Loans shall have been terminated, (ii) to make application on trademarks, as appropriate in the reasonable business judgment of Grantor, and (iii) to preserve and maintain all rights in trademarks and applications and registrations of the Trademarks that are material to the use and operation of the business. Any expenses incurred in connection with such applications shall be borne by the Grantor. The Grantor shall not abandon any right to file a trademark application, or any pending trademark application or trademark registration that is material to the use and operation of the business without the consent of the Grantee, which consent shall not be unreasonably withheld. Notwithstanding the foregoing, Grantee acknowledges that Grantor may abandon the Trademarks that are so designated on Schedule 1, and consents to that action.

No course of dealing between the Grantor and the Grantee, nor any failure to exercise, nor any delay in exercising, on the part of the Grantee, any right, power or privilege hereunder or under the Loans shall operate as a waiver thereof; nor shall any single or partial exercise of any right, power or privilege hereunder or thereunder preclude any other or further exercise thereof or the exercise of any other right, power or privilege.

The provisions of this Grant of Security Interest are severable, and if any clause or provision shall be held invalid and unenforceable in whole or in part in any jurisdiction, then such invalidity or unenforceability shall affect only such clause or provision, or part thereof, in such jurisdiction, and shall not, in any manner, affect such clause or provision in any other jurisdiction, or any other clause or provision of this Grant of Security Interest in any jurisdiction.

This Grant of Security Interest cannot be altered, amended or modified in any way, except as specifically provided above or by a writing signed by the parties hereto.

All of the Grantee's rights and remedies with respect to the Trademarks, whether established hereby or by any other agreements or by law shall be cumulative and may be exercised singularly or concurrently.

This Grant of Security Interest shall be binding upon the Grantor and its successors and assigns, and shall inure to the benefit of the Grantee, its nominees and assigns.

This Grant of Security Interest shall be governed by and construed in accordance with the laws of the State of Florida.

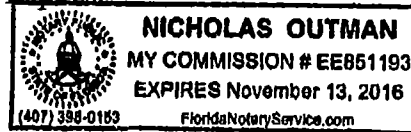
