**RELEASE OF SECURITY INTEREST
IN TRADEMARK**

This RELEASE OF SECURITY INTEREST IN TRADEMARK, effective as of January 15, 2014, is granted by Silicon Valley Bank (the "Lender"), with its principal office at 3003 Tasman Drive, HG 150, Santa Clara, California 95054, as follows:

WITNESSETH

WHEREAS, TiqIQ, Inc., a Delaware corporation (the "Grantor"), has heretofore granted to the Lender a security interest in certain intellectual property rights, including, without limitation, the trademark and servicemark rights, applications to register and registrations of the same and like protections, and the entire goodwill of the business of the Grantor connected with and symbolized by such trademarks, including without limitation those set forth on Schedule A attached hereto (collectively, the "Trademarks"), pursuant to the Intellectual Property Security Agreement, entered into as of May 10, 2013 (the "Security Agreement"), by and between the Bank and the Grantor;

WHEREAS, the Security Agreement has terminated and is of no further force or effect, and all security interests granted by the Grantor pursuant to the Security Agreement have been released; and


WHEREAS, the Lender wishes to release and restore all right, title and interest in and to the Trademarks to the Grantor and to dissolve any and all liens and encumbrances respecting the Trademarks including, without limitation, the Trademarks shown on the attached Schedule A hereto.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Lender hereby, without recourse and without representation or warranty of any kind (either express or implied), releases, discharges, quit claims and relinquishes unto the Grantor any and all right, title and interest in and to the Trademarks granted to the Lender by the Grantor, including, without limitation, by the Security Agreement, which was recorded on May 14, 2013, at Reel 5027, Frame 0546 in The United States Patent and Trademark Office ("USPTO"); and further Lender hereby expressly releases all other rights it may have under the Security Agreement with respect to the Trademarks and all other intellectual property described therein, and expressly cancels the Security Agreement in its entirety, effective as of the date above written.

The Lender authorizes the recordation of this Release of Security Interest in Trademark with the USPTO and any other applicable registry or government office necessary to effect the release of its security interest in the Trademarks.
