RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

THIS RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this "Release") is made as of December 31, 2013 ("Effective Date") by Golub Capital LLC, a Delaware limited liability company, in its capacity as agent for the Lenders, as such term is defined in the below defined Trademark Security Agreement (in such capacity, "Agent"), in favor of the grantors listed on the signature pages to the Trademark Security Agreement (each, individually, a "Grantor" and collectively, jointly and severally, the "Grantors").

WHEREAS, reference is made to that certain Second Lien Credit Agreement dated as of October 31, 2012 (as amended, restated, supplemented, or otherwise modified from time to time, the "Credit Agreement"), by and among the lenders identified on the signature pages thereof, Grantors, Entrust Holdings, Inc., a Delaware corporation, and Agent;

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement dated as of October 31, 2012 (as amended, restated, supplemented, or otherwise modified from time to time, the "Trademark Security Agreement"), by and among Grantors and Agent, Grantors granted to Agent a security interest in all of Grantors' right, title and interest in and to the Trademark Collateral (as such term is defined in the Trademark Security Agreement);

WHEREAS, Agent now desires to release its security interest in the Trademark Collateral, including, without limitation, the trademark registrations and applications listed on Schedule 1 hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby covenants and agrees as follows:

1. Without representation or warranty of any kind or nature, Agent hereby terminates, releases, and discharges its security interest in the Trademark Collateral granted pursuant to the Trademark Security Agreement and reassigns to Grantors all right, title, and interest of Agent in the Trademark Collateral pursuant to the Trademark Security Agreement.

2. Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts, in each case at Grantors' expense, as may be reasonably necessary to effect the release of the security interest in the Trademark Collateral contemplated hereby.
