RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Release") is made as of January 17, 2014 (the "Effective Date"), by Bank of America, N.A., as collateral agent (in such capacity, the "Collateral Agent"), in favor of American Petroleum Tankers LLC (the "Grantor").

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement between the Grantor and the Collateral Agent dated as of April 2, 2013 (the "Trademark Security Agreement"), the Grantor pledged and granted to the Collateral Agent a lien on and security interest in all of its right, title and interest in and to the Trademark Collateral (as defined in the Trademark Security Agreement) including, without limitation, the trademark applications set forth on Schedule I hereto, along with the goodwill associated therewith;

WHEREAS, the Trademark Security Agreement was recorded with the Assignment Division of the U.S. Patent & Trademark Office on April 3, 2013, at Reel 4997 and Frame 0022;


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates the Trademark Security Agreement, and hereby terminates, cancels, discharges, reassigns and releases any and all liens and security interests it has in and against the Trademark Collateral arising under the Trademark Security Agreement.

If and to the extent the Collateral Agent has acquired any right, title or interest in or to any of the Trademark Collateral, it hereby irrevocably re-assigns and re-transfers all such rights, title and interest to the Grantor.

The Collateral Agent shall take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, and at Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.
