## TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT is made between Miami Tribe of Oklahoma Business Development Authority, a Tribal Enterprise of the Miami Tribe of Oklahoma, a federally recognized Indian tribe ("Assignor"), and David Hatton (a United States Individual) and Ronnie W. Harris (a United States Individual ("Assignee").

WHEREAS, Assignor is the listed owner of record of the marks identified by the U.S. trademark registration numbers listed in Exhibit A ("Marks");

WHEREAS, Assignor has sold, assigned and/or otherwise transferred over such portion of the business associated with the Marks to the Assignee; and


WHEREAS, the Assignee is desirous of acquiring the entire right, title and interest in and to the Marks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. Assignor does hereby sell, transfer, assign and otherwise convey to the Assignee, its successors and assigns all of Assignor's right, title and interest throughout the world, in the following:
  - (i) the Marks listed in Exhibit A, and any registrations and renewals thereof;
  - (ii) the goodwill of that portion of Assignors business connected with, pertaining to, and symbolized by the Marks; and
  - (iii) the ownership of all causes of action for, and claims for damages by reason of infringement of the Marks, which actions arose prior to the date of execution hereof.
2. This Trademark Assignment shall inure to the benefit of, and shall be binding upon, the successors and assigns of the parties.
3. Assignor hereby agrees that the Assignee shall have the right to record this instrument of assignment.
