**CERTIFICATE OF AMENDMENT TO THE  
FOURTH AMENDED AND RESTATED OPERATING AGREEMENT

THIS CERTIFICATE is made and entered into as of the 10<sup>th</sup> day of September, 2012 by the undersigned, as Manager of ROMANE FRAGRANCES, LLC, an Illinois limited liability company, n/k/a TRU FRAGRANCE & BEAUTY LLC (herein "Company").

**RECITALS**


A. On December 21, 2011, the Company adopted the trade name "Tru Fragrance & Beauty" as an assumed name for the Company in accordance with the terms and provisions of section 1-20 of the Illinois Limited Liability Company Act and section 2.3 of the Fourth Amended and Restated Operating Agreement of the Company.

B. Pursuant to the provisions of section 2.2 of the Fourth Amended and Restated Operating Agreement of the Company, the undersigned, as Manager of the Company, has the power, from time to time, to change the name of the Company.

C. By Articles of Amendment dated September 10, 2012, filed in the office of the Secretary of State of the State of Illinois, the undersigned, as Manager, has amended the Articles of Organization of the Company to change the name of the Company from "Romane Fragrances, LLC" to "Tru Fragrance & Beauty LLC".

D. Pursuant to section 13.1(a) of the Fourth Amended and Restated Operating Agreement, the undersigned, as Manager of the Company, further has the power to amend the Fourth Amended and Restated Operating Agreement of the Company to reflect the new name of the Company.

NOW, THEREFORE, the undersigned, as Manager of the Company, does hereby amend the Fourth Amended and Restated Operating Agreement of the Company by deleting the name "ROMANE FRAGRANCES, LLC" in each place on every page where it appears and by substituting the name "TRU FRAGRANCE & BEAUTY LLC" in its place and stead.
