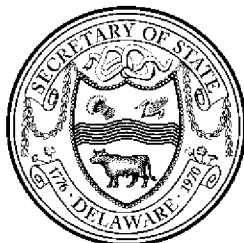

C. §1-101, et seq.) (the "DGCL") and the Delaware Limited Liability Company Act (6 Del. C. § 18-101, et seq.).

1. The Company filed its original certificate of incorporation with the Secretary of State of the State of Delaware and was first incorporated on May 2, 2005, in the State of Delaware, and was incorporated in the State of Delaware immediately prior to the filing of this Certificate of Conversion to Limited Liability Company.
