**CERTIFICATE OF MERGER
OF

Pursuant to Title 8, Section 252 of the Delaware General Corporation Law, the undersigned corporation executed the following Certificate of Merger:

FIRST: The name of each constituent corporation is Septodont, Inc., a corporation of the State of New York, and Novocol, Inc., a corporation of the State of Delaware.

SECOND: The Merger Agreement has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations pursuant to Title 8, Section 252.

THIRD: The name of the surviving corporation is Septodont, Inc., a corporation of the State of New York.

FOURTH: The Certificate of Incorporation of the surviving corporation shall be its Certificate of Incorporation.

FIFTH: The merger is to become effective on the 31st day of December 2012.

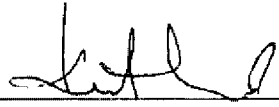
