To the extent the Marks include any United States trademark application that is based on an intent-to-use, Assignor acknowledges that this Assignment is to a successor to that portion of such Assignor's business to which the Marks pertain, in accordance with 15 U.S.C. §1060(a)(1).

Assignor authorizes and requests the Commissioner of Patents and Trademarks of the United States and the equivalent office in each country in which the Marks are registered to record Assignee as the owner of any and all of such Assignor's right, title and interest in the Marks and issue any trademarks which may be granted on any applications included in the Marks to Assignee as assignee of such Assignor's entire right, title and interest therein and thereto.


