**DOMAIN NAME AND TRADEMARK  
TRANSFER AGREEMENT**

This Domain Name and Trademark Transfer Agreement ("Agreement") is made and entered into this 20th day of October, 2013 by and between SUMMIT INDUSTRIES, INC., a Georgia corporation, ("ASSIGNOR") and MANNA PRO PRODUCTS, LLC, a Missouri limited liability company ("ASSIGNEE").

Background. The parties have entered into an Asset Purchase Agreement dated April 23, 2011 ("Purchase Agreement") and related Ancillary Agreements. Capitalized terms used, but not defined herein shall have the meanings ascribed to them in the Purchase Agreement. Pursuant to the Purchase Agreement, upon the payment of full of all amounts due under the Note, then the parties are to enter into this Agreement on the Transfer Date. Contemporaneously with the execution of this Agreement on or about the Transfer Date, the Assignee shall execute the Trademark License Back Agreement.

For and in consideration of the mutual covenants, promises and agreements contained herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Assignment of Marks

ASSIGNOR hereby sells, transfers and assigns to ASSIGNEE all of its right, title and interest in and to the following trademarks (including service marks and other marks) ("Marks"), including the goodwill of the business associated with and symbolized by the Marks, and all rights in any registrations or applications for registration for the Marks, along with the right to recover for damages and past infringements thereof. ASSIGNOR covenants and agrees that it will, whenever so requested by ASSIGNEE, execute and deliver such further instruments and perform any other reasonable acts that ASSIGNEE may require as may be necessary or convenient for vesting in ASSIGNEE the full benefit of all of the rights and premises hereby assigned and provide evidence to support any of the foregoing in the event such evidence is in the possession or control of ASSIGNOR, including, without limitation, further documentation and instruments necessary for purposes of recording this assignment with the U.S. Patent and Trademark Office ("PTO")
