1. Assignor hereby assigns to Assignee the entire right, title and interest in and to all trademarks, whether registered or not, which subsist anywhere in the world and which are owned by Assignor as of the Effective Date (as defined in Clause 2 below), including without limit those trademark applications and registrations listed in Schedule 1 attached to this Assignment, together with the goodwill of the business relating to the products and services in connection with which the trademarks are used and/or for which they are registered (collectively, the “Trademarks”), and Assignee accepts from Assignor absolutely all rights, title and interests in and to the Trademarks.
2. The Assignment is effective from September 1, 2013 (“Effective Date”).
3. This Assignment is governed by and shall be construed in accordance with the laws of the State of California.

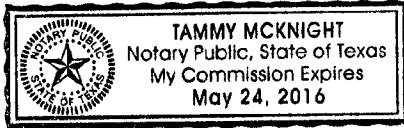

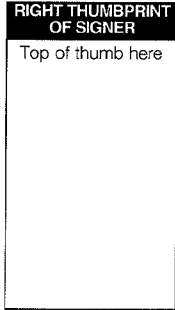

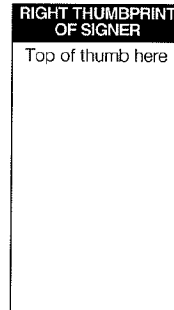
