## ASSIGNMENT OF TRADEMARKS AGREEMENT

<sup>24<sup>th</sup></sup> This ASSIGNMENT OF TRADEMARK AGREEMENT (the "Agreement") is entered into as of the 24<sup>th</sup> day of October, 2013 (the "Assignment"), by and between SPLINTEK, INC., a corporation duly organized and existing under the laws of the State of Missouri, previously known as Power Products, Inc. before amendment changing name to Splintek, Inc., a copy of which is attached hereto as Exhibit A, and having its principal place of business at 3325 Wyoning Street, Kansas City, Missouri, 64111-3714 ("Assignor"), and PENFORD PRODUCTS CO., a corporation duly organized and existing under the laws of the State of Delaware and having its principal place of business at 7094 S. Revere Parkway, Centennial, Colorado 80112-3932 ("Assignee").

### WITNESSETH:

**WHEREAS**, Assignor has adopted, used and/or licensed the use of, and is using and/or licensing the use of, the trademark names: Pegetables (Trademark Reg. No. 3,160,874) and Peggies (Trademark Reg. No. 3,671,013) and trademarks for celery shaped animal chews (Trademark Reg. No. 3,499,178) and corn shaped animal chews (Trademark Reg. No. 3,492,730) (hereinafter collectively the "Marks and Regulations"), a copy of such Registrations is attached hereto as Exhibit; and

**WHEREAS**, Assignee is desirous of acquiring all right, title and interest in, to and under the Marks and the Registrations.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Assignor has sold, assigned and transferred, and by these presents does hereby sell, assign and transfer unto Assignee the full exclusive right, title and interest, throughout the world, in, to and under the Marks and the Registrations, together with the goodwill of the business symbolized by the Marks and the right to sue for and collect on all claims for damages by reason of past infringement of the Marks or the Registrations. At Assignee's request, Assignor shall provide non-monetary assistance to Assignee in registering, perfecting, enforcing or defending Assignee's rights in the Marks and Registrations.

2. As of the date of execution of this Agreement, the Assignor shall have no further rights, obligations or liabilities of any kind whatsoever to the above-mentioned domain names.
