RELEASE OF TRADEMARK COLLATERAL

THIS RELEASE OF TRADEMARK COLLATERAL (this "Release") is made as of January 23, 2014, by WELLS FARGO BANK, NATIONAL ASSOCIATION, as administrative agent (in such capacity as the "Administrative Agent"), the secured party under the Security Agreement referred to below.

W I T N E S S E T H:

WHEREAS, CQ Holding Company, Inc., a Delaware corporation (the "Parent"), Casino Queen Inc., an Illinois corporation (the "Borrower"), and the other entities which from time to time through the date hereof became a party thereto (the foregoing, including the Parent and the Borrower hereinafter being collectively referred to as the "Grantors"), executed that certain First Lien Security Agreement, dated as of December 26, 2012 (the "Security Agreement"), pursuant to which the Grantors granted a security interest to the Administrative Agent in certain trademarks and other intellectual property of the Grantors; and

WHEREAS, one or more Grants of Security Interest – Trademarks executed in connection with the Security Agreement were recorded with the United States Patent and Trademark Office; and

WHEREAS, the Administrative Agent has agreed to release its lien on the trademarks and trademark applications of the Grantors identified on Exhibit A attached hereto and made a part hereof (the "Released Collateral").

NOW, THEREFORE, in consideration of the promises and other good and valuable consideration, receipt of which is hereby acknowledged, the Administrative Agent hereby releases all its rights in and to the Released Collateral and reconveys to the persons legally entitled thereto all of the Administrative Agent's right, title and interest in and to the Released Collateral, all without warranty or representation of any kind.
