Assignment of Rights to Trademark

This Assignment of Rights to Trademark is between Streamlines Health, LLC ("Assignor"), a Minnesota limited liability company, located at 6200 Shingle Creek Parkway, Suite 400, Minneapolis, Minnesota 55430, and Fortify Technologies, LLC ("Assignee"), a Minnesota limited liability company, located at 6200 Shingle Creek Parkway, Suite 400, Minneapolis, Minnesota 55430.

RECITALS

WHEREAS, Assignor owns all rights, title and interest in and to Pending U.S. Trademark Application Serial No. 86142908 ("Hat Trick Motion Trademark").

WHEREAS, Assignor desires to assign to Assignee all its right, title and interest in and to the Hat Trick Motion Trademark.

NOW, THEREFORE, in consideration of \$1.00 and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

AGREEMENT

1. **Assignment.** Assignor assigns and transfers to Assignee all its right, title and interest in and to the Hat Trick Motion Trademark and any and all related intellectual property as of the date hereof to the Assignor.
2. **Acceptance.** Assignee accepts the assignment of Assignor's entire right, title, and interest to the Hat Trick Motion Trademark.
3. **Miscellaneous.** This Agreement shall be binding on and inure to the benefit of the parties and their successors and assigns. This Agreement may be executed in several counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same document. Any party shall, however, deliver an original signature of this Agreement to the other party upon request. Each party warrants to the other that it has full power and authority to execute and perform this Agreement in accordance with its terms without the consent or approval of any third party. If any provision of this Agreement is held by the final judgment of any court of competent jurisdiction to be illegal, invalid or unenforceable, the validity of the remaining portions or provisions must not be impaired or affected, and the rights and obligations of the parties must be construed and enforced as if this Agreement did not contain that certain part, term or provision held to be illegal, invalid or unenforceable. This Agreement constitutes the entire agreement between Assignor and Assignee and may be amended or altered only by written agreement executed by both parties, and supersedes all prior agreements, whether written or oral, between the parties. This Agreement and the rights and obligations of the parties hereto, must be construed and enforced in accordance with the laws of the state of Minnesota.
