## DEED OF ASSIGNMENT

THIS ASSIGNMENT is made the 21<sup>st</sup> day of June Two Thousand and Thirteen (2013)

### BETWEEN

- A. **COOKSON SINGAPORE PTE LTD**, a corporation organized and existing under the laws of Singapore, with its address at 1 Marina Boulevard, #28-00, Singapore 018989 (and former address being 14 Tuas Avenue 10, Singapore 639138) (hereinafter called the "Assignor") of the one part;

### AND

- B. **PANASONIC INDUSTRIAL DEVICES MATERIALS SINGAPORE PTE LTD** (previously known as Panasonic Electric Works Electronic Materials Singapore Pte. Ltd.), a corporation organized and existing under the laws of Singapore, with its address at 12 Joo Koon Road, Singapore 628975 (hereinafter called the "Assignee").

(Each a "Party" and collectively, "Parties")

### WHEREAS

- (1) The Parties entered into an agreement dated 1 November 2010 relating to the sale and purchase of the epoxy mould compound business of the Assignor ("APA") pursuant to which the Assignor agreed to assign certain Trade Marks (as defined below) to the Assignee together with the goodwill of the business symbolised by the Trade Marks.
- (2) This Deed of Assignment is required to be executed and delivered by the Assignor, pursuant to Clause 2 of the APA.

### NOW THEREFORE THE PARTIES AGREE AS FOLLOWS:

#### 1. DEFINITIONS

- "Trade Marks" shall mean the trade mark PLASKON, including but not limited to the applications and registrations as set out in Schedule A;
- "Territory" shall mean for each Trade Mark the territories covered by that Trade Mark;
- "Effective Date" 1 November 2010

#### 2. ASSIGNMENT

- 2.1 In consideration of the sum of S\$10, the adequacy and sufficiency of which is acknowledged, from and with effect from the Effective Date, the Assignor irrevocably conveys, transfers and assigns unto the Assignee in perpetuity, all of Assignor's right title and interest in and to the Trade Marks in the Territory, including without limitation:
- (a) all of Assignor's statutory and common law rights, title and interest in the Trade Marks together with the goodwill of the business symbolised by the Trade Marks and the benefit of any applications for registration comprised in the Trade Marks, with the intention that, when the applications are granted, all of

Assignor's rights, title and interest in and to the registrations and the goodwill therein shall vest in the Assignee;

- (b) Assignor's right to apply for the Trade Marks and any marks similar thereto and including any stylised or logo form thereof in any part of the world and all such Trade Marks granted in the future therein;
- (c) all of Assignor's rights and interests howsoever arising and whether subsisting at the date of this Deed in connection with the use, exploitation and marketing, including without limitation Assignor's rights under any licence agreements and any other contractual arrangement in respect of the Trade Marks;
- (d) Assignor's right on behalf of the Assignee and its successors and assignees to carry on its business under the Trade Marks and to represent itself as carrying on such business in succession to the Assignor; and
- (e) all of Assignor's benefits, privileges, rights to sue, recover damages and obtain relief for any past, current or future infringement, misappropriation or violation of any of the foregoing rights, including all of Assignor's present and future rights and causes of action whenever and wherever accrued or to accrue in respect of any infringement, passing off, unfair competition and/or dilution anywhere in the world of any of the Trade Marks or any of Assignor's rights referred to above; and
- (f) Assignor's rights of the same or similar effect or nature as or to those referred to above which now or in the future may subsist throughout the world.

### 3. ENTIRE AGREEMENT

This assignment (including Schedule A hereto), and the APA (including all Exhibits, Annexes, Schedules thereto) set forth the entire understanding of the Parties with respect to the Trade Marks and supersede all prior agreements and understandings, oral or written, between or among the Parties relating the subject matter hereof.

### 4. GOVERNING LAW AND JURISDICTION

- 4.1 This Deed shall be governed by, and construed in accordance with, the laws of Singapore.
- 4.2 The Parties irrevocably agree to submit to the non-exclusive jurisdiction of the Singapore courts with respect to the enforcement and interpretation of this Deed. For avoidance of doubt, this clause shall not limit the right of Assignee to take proceedings in any court of competent jurisdiction to enforce the terms of this Deed.
