TRADEMARK ASSIGNMENT

WHEREAS, Assignor has sold, assigned and/or otherwise transferred over such portion of the business associated with the Marks to the Assignee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Assignor does hereby sell, transfer, assign and otherwise convey to the Assignee, its successors and assigns, all of Assignor's right, title and interest throughout the world, in the following:

- (i) the Marks and any applications, registrations, and renewals thereof;
- (ii) the goodwill of that portion of Assignor's business connected with, pertaining to, and symbolized by the Marks; and
- (iii) the ownership of all causes of action and claims for damages for infringement of the Marks, including actions arising prior to the date of this assignment.


2. This Trademark Assignment shall inure to the benefit of, and shall be binding upon, the successors and assigns of the parties.

3. Assignor hereby agrees that the Assignee shall have the right to record this instrument of assignment.
