**ARTICLES OF ENTITY CONVERSION OF  
BUNZL DISTRIBUTION USA, INC. 0772503-3**

The undersigned, on behalf of the company set forth below, pursuant to Section 13.1-1010.4 of the Virginia Limited Liability Company Act and Section 13.1-722.9 of the Virginia Stock Corporation Act, as amended (the "VSCA"), states as follows:

1. The name of the Company immediately prior to the filing of these Articles of Conversion (the "Articles") is **BUNZL DISTRIBUTION USA, INC.** (the "Company") and the name of the Company immediately following the filing of the Articles shall be **BUNZL DISTRIBUTION USA, LLC**, a Virginia limited liability company.
2. The plan of entity conversion is as set forth in Exhibit A (the "Plan of Conversion") attached hereto and the articles of organization of the Company, to be in effect immediately following the filing of the Articles, is as set forth in Annex I to the Plan of Conversion.
4. The conversion was approved, by the sole shareholder of the Company and by the unanimous consent of the Board of Directors, in accordance with the terms of the Section 13.1-722.11 of the VSCA and the terms of the Company's articles of incorporation.
5. The conversion shall be effective at 11:59 p.m., Eastern Standard Time, on December 31, 2013 (the "Effective Time").

PLAN OF CONVERSION

OF

BUNZL DISTRIBUTION USA, INC.  
A VIRGINIA CORPORATION

INTO

BUNZL DISTRIBUTION USA, LLC  
A VIRGINIA LIMITED LIABILITY COMPANY

1. *Conversion.* Bunzl Distribution USA, Inc., a Virginia corporation (the "Company") shall convert into Bunzl Distribution USA, LLC, a Virginia limited liability company (the "VA LLC"), in accordance with this plan of entity conversion (the "Conversion"). The Conversion shall be effective as of 11:59 p.m., Eastern Standard Time, on December 31, 2013 (the "Effective Time"). After the Effective Time, the Company shall continue its existence in the organizational form of the VA LLC.

2. *Manner and Basis of Conversion.* At the Effective Time, each share of the outstanding Common Stock of the Company shall, by virtue of the Conversion and without any action on the part of the Company or the shareholder of the Company, shall be converted automatically, without additional consideration, into one unit of membership interest of the VA LLC.

3. *Articles of Organization.* The Articles of Organization at the Effective time shall be those attached hereto as Annex 1, and shall continue as the Articles of Organization thereafter until duly amended in accordance with their terms and the Virginia Limited Liability Company Act.

4. *Effect of Conversion/Domestication.* At the Effective Time, the Conversion shall have the effect stated in Section 13.1-722.13 of the Virginia Stock Corporation Act.

Pursuant to Chapter 12 of Title 13.1 of the Code of Virginia, **BUNZL DISTRIBUTION USA, LLC** states as follows:

2. The name of the company's initial registered agent is Corporate Creations Network, Inc., which is a foreign stock corporation authorized to transact business in Virginia.


