## ASSIGNMENT OF SERVICE MARK REGISTRATION

THIS ASSIGNMENT, dated and effective as of December 31, 2013 is **from SCRI Holdings, LLC**, a corporation organized under the laws of the State of Delaware, with a business address of One Park Plaza, Nashville, Tennessee 37203 (“Assignor”), to **CBJD Partners, LLC**, a limited liability company organized under the laws of the State of Tennessee, with a business address of 401 Bowling Avenue, Nashville, Tennessee 37205 (“Assignee”).

### WITNESSETH:

WHEREAS, Assignor is the owner of the service mark registration for **SCRI SARAH CANNON RESEARCH INSTITUTE & Design** as illustrated on Schedule A hereto (the “Mark”), as recorded with the United States Patent & Trademark Office (“USPTO”) namely, U.S. Reg. No. 3,621,787 (the “Registration”);

WHEREAS, Assignee is interested in acquiring the Registration, together with the goodwill of the business connected with the use of and symbolized by the Mark;

WHEREAS, Assignor desires to assign to Assignee, and Assignee desires to receive from Assignor, all rights to the Registration, together with the goodwill of the business connected with the use of and symbolized by the Mark;

NOW, THEREFORE, in consideration of Assignor’s agreement to use the Mark in accordance with the terms of the License Agreement executed by and between the Parties on January 28, 2014, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby assigns to Assignee and its successors, assigns and nominees without any restrictions, reservations, or limitations:

1. All of Assignor’s rights in and to the Registration, together with the goodwill of the business connected with the use of and symbolized by the Mark; and
2. The sole right to enforce rights in said Mark and Registration, with the right to sue for and recover for Assignee’s own use accrued profits or damages for any and all causes of action, claims, and demands and other rights for infringements thereof, including, but not limited to past infringements with respect to which Assignor waives any right to receive any portion thereof.

Assignor covenants that Assignor has the full right to enter into this Assignment and further agrees without further consideration to cause to be performed such other lawful acts and to be executed such further assignments and other lawful documents as Assignee may from time to time reasonably request to effect fully this Assignment and to permit Assignee to be duly recorded as the legal and record owner of each of the rights hereby conveyed.

WHEREFORE, Assignor hereby executes the aforementioned assignment, effective as of the day and year first above written.
