ASSIGNMENT AGREEMENT

Victorinox A.G., a Swiss corporation, with an address at Schmiedgasse 57, CH-6438, Ibach-Schwyz, Switzerland ("Assignee") (collectively, "the Parties").

- A. Assignor and Assignee are related companies and are joint owners of undivided interests in and to the trademark **SWISS ARMY**, used in connection with handtools, namely multifunction pocketknives, subject of incontestable United States Trademark Registration No. 2,806,013, dated January 20, 2004 (hereinafter collectively the "Mark"); and
- B. The Parties desire to consolidate all ownership of the Mark in Assignee, together with the goodwill associated therewith and the registration thereof.

- 2. Assignor agrees to execute and deliver to Assignee any and all further acts, conveyances, transfers, assignments, instruments, documents and assurances as Assignee may reasonably require to consolidate, vest, and record in Assignee complete, consolidated and sole ownership of and title in the Mark or otherwise to evidence the full and effective implementation and consummation of this Assignment Agreement.
