

MorphoTrust USA, Inc., a Delaware corporation (the "Company"), which desires to merge with Identix Incorporated, a Delaware corporation and a wholly owned subsidiary of the Company ("Identix"), does hereby certify:

FIRST: The names and states of incorporation, as applicable, of the constituent companies to this merger are as follows:
