RELEASE OF SECURITY INTEREST IN PATENT AND TRADEMARKS dated as of January 28, 2014 (this “Release”), by BANK OF AMERICA, N.A., as Collateral Agent (the “Collateral Agent”). Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement or the Guarantee and Collateral Agreement, as applicable, referred to below.

A. Reference is made to (i) that certain ABL Guarantee and Collateral Agreement executed by Deluxe Entertainment Services Group Inc, Deluxe Laboratories, Inc., Deluxe Digital Studios, Inc., Deluxe Media Creative Services Inc., Deluxe Media Services LLC, Company 3, LLC, DX Holdings LLC, and the Subsidiaries of Deluxe Entertainment Services Group Inc. (“Deluxe”) as of January 3, 2012 (the “ABL Loan GCA”) and (ii) that certain Patent and Trademark Security Agreement executed by Deluxe Digital Studios as of January 3, 2012 (together with the ABL GCA, the “Security Agreements”).

B. Pursuant to the Security Agreements, the Grantors granted to the Collateral Agent, for the benefit of the Secured Parties, a security interest in all right, title or interest of the Grantors in, among other things, the Patents and Trademarks of the Grantors set forth on Schedule I & Schedule II hereto (collectively, the “Patent and Trademark Collateral”), which security interests were recorded with the United States Patent & Trademark Office on February 1, 2012 at Reel/Frames 27637/434 and 4709/141.

C. In connection with Deluxe Digital Studios, Inc.’s merger with and into Deluxe Media Inc., the Grantors have informed the Collateral Agent of their desire to obtain the release of all right, title, and interest of the Collateral Agent in and to the Patents and Trademarks granted under the Security Agreement.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent does hereby release, relinquish and discharge any and all security interests it has against the Trademark Collateral. This Release is made without representation or warranty by, or recourse to, the Collateral Agent or any other Secured Party.
