dated as of January 27, 2014, by FC CRESTONE COLORADO 07 LLC, a Colorado limited liability company (the "Secured Party").


**WHEREAS**, JOHN ATENCIO GOLDSMITH, LTD., a Colorado corporation (the "Grantor") and the Secured Party entered into a Trademark Security Agreement, dated as of October 5, 2007 (the "Security Agreement") which Security Agreement was recorded with the United States Patent and Trademark Office on October 11, 2007, at Reel 003637, Frame 0737, for the purpose of collateral security for all indebtedness and obligations of the Grantor to the Secured Party arising under a certain Loan and Security Agreement (as defined in the Security Agreement);

**WHEREAS**, pursuant to the Loan Agreement and the Security Agreement, the Grantor pledged and assigned to the Secured Party, and granted the Secured Party a security interest with power of sale in, the Trademarks (as defined in the Security Agreement), including, without limitation, the trademarks listed on **Exhibit A** hereto. The Trademarks are referred to herein collectively as the "Intellectual Property"; and

**WHEREAS**, the Secured Party has agreed to terminate and release its security interest in the Intellectual Property as herein provided:

**NOW, THEREFORE**, for valuable consideration the Secured Party hereby terminates and releases its security interest in the Intellectual Property, including, without limitation, the Trademarks listed on Exhibit A hereto, and the Secured Party hereby assigns and transfers to the Grantor, without representation, warranty or recourse, all of the Secured Party's right, title and interest in and to such Intellectual Property, effective as of the date set forth above.


