## TRADEMARK ASSIGNMENT

**THIS TRADEMARK ASSIGNMENT** (“Assignment”) is entered into as of this 7th day of January, 2014 (the “Effective Date”), by and among SPX Corporation, a Delaware corporation (“Assignor”), EGS Electrical Group LLC, a Delaware limited liability company (“Assignee”), and GSEG LLC, a Delaware limited liability company (“GSEG”).

A. By virtue of a trademark license agreement dated December 30, 1999, between General Signal Corporation and Sola Australia Limited (the “Sola Australia License Agreement”), which was subsequently acquired by Eaton Corporation as a result of Eaton’s acquisition of Sola Australia Limited, Assignor has granted certain rights to use the SOLA trademark to Eaton Corporation which has consented to this Assignment;

B. General Signal Corporation and GSEG, a wholly-owned subsidiary of EGS, entered into a Trademark License Agreement dated September 15, 1997, whereby General Signal Corporation granted GSEG a license to use the SOLA trademark (the “GSEG License Agreement”);

C. Assignor does not use the SOLA trademark other than through its licensees;

D. General Signal Corporation was subsequently merged into SPX Corporation, and Assignor now owns the SOLA trademark and variations thereof (the “Marks”), and owns other transferable rights associated with the Marks including, but not limited to, the goodwill of said Marks arising from use of the Marks by Assignor’s licensees, and is the owner of all right, title and interest in and to the registrations for the Marks set forth in the attached Schedule 1, together with whatever rights Assignor may otherwise have in the Marks worldwide and Assignor’s rights and obligations in and to the Sola Australia License Agreement (collectively the “Trademark Assets”); and

E. Pursuant to a Limited Liability Company Interest Purchase Agreement entered into as of December 3, 2013, by and among EGS Electrical Group LLC, Emerson Electric Co., SPX Corporation, and SPX Holdings, Inc., Assignor has agreed to assign the Trademark Assets to Assignee.

Therefore, in consideration of the mutual covenants and obligations contained herein and in the Limited Liability Company Interest Purchase Agreement, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Assignor and Assignee agree as follows:

Effective as of the Effective Date, Assignor does hereby sell, assign, and transfer to Assignee, its successors and assigns, all of its right, title, and interest, in and to the Trademark Assets, together with any and all of the goodwill of the business symbolized by and associated with said Mark, and all income, royalties, fees, damages, and payments now or hereafter due or payable in respect thereto, and in and to any and all causes of action (either in law or in equity), and the right to enforce any rights and file any causes of action, including the right to recover damages, for any past, present, or future infringement, misappropriation and/or dilution of the Marks.

Assignor agrees to execute or procure any further necessary assurance of title to the Trademark Assets; and at any time, upon the request and at the expense of Assignee, will execute and deliver any and all papers that may be necessary or desirable to perfect the title to the Trademark Assets in Assignee, its successors, assigns or other legal representatives; and to make a record with any and all government agencies, authorities, courts, tribunals, or third parties, of the fact that Assignee owns all right, title and interest in and to the Trademark Assets, and any and all goodwill associated therewith, and that Assignor no longer has any right, title or interest, of any kind or nature, in or to the Trademark Assets.

Assignee assumes all of Assignor's right, title, interest and obligations under the Sola Australia License Agreement accruing on or after the Effective Date.

Effective as of the Effective Date, the GSEG License Agreement shall be terminated.

This Assignment may be executed in counterparts, each of which shall be deemed to be an original, and all of which together shall constitute one and the same instrument.
