Dear Steve:

As you know, I have served as the attorney for Healthcare Team Training, LLC n/k/a Synensis, LLC ("Company") in connection with the legal change of the Company's name. The name was changed pursuant to the requirements of O.C.G.A. § 14-11-210 and the new name of the Company complies with the requirements of O.C.G.A. § 14-11-207.

In this connection, I have examined (i) the Constitution and laws of the State of Georgia, (ii) the Operating Agreement of the Company, and (iii) such other documents and matters of laws I have deemed relevant and necessary in rendering this opinion.

Based upon the foregoing, I am of the opinion that as of this date:

The Company is a limited liability company duly created on April 26, 2005 and validly existing under the Constitution and laws of the State of Georgia.

(1) The Articles of Amendment changing the name of the Company from Healthcare Team Training, LLC to Synensis, LLC effective January 1, 2014 ("Articles of Amendment") has been duly adopted by a unanimous action of the members of the Company and constitutes a valid action on the part of the Company.

(2) The Articles of Amendment was properly and timely filed with the Georgia Secretary of State.

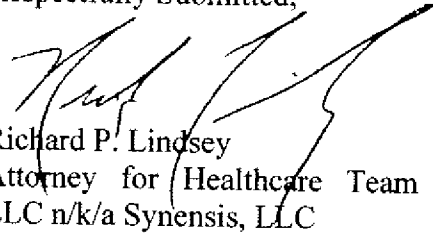
(3) The Georgia Secretary of State issued a Certificate of Name Change dated December 30, 2013 certifying that the name of the Company is changed from Healthcare Team Training, LLC to Synensis, LLC effective January 1, 2014 and the Company filed all required documents and paid all required fees to accomplish the same.

(4) The adoption of the Articles of Amendment by the Company was properly completed under the terms of the Operating Agreement.

ARTICLES OF AMENDMENT OF HEALTHCARE TEAM TRAINING, LLC

V.

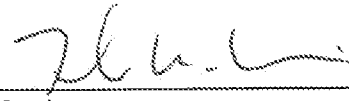
The date for the adoption of this amendment is January 1, 2014 at 12:01 a.m. Eastern Standard Time.
