**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of December <sup>30<sup>th</sup></sup>, 2013 (this "Release"), is made by General Electric Capital Corporation, as Collateral Agent ("Agent"), in favor of Benchmark Medical Holdings, Inc. ("Debtor") as follows:

WHEREAS, pursuant to the First Lien Trademark Security Agreement, dated December 27, 2005 (the "Security Agreement"), and recorded with the U.S. Patent and Trademark Office on January 10, 2006 at Reel/Frame No. 3248/0524, and the Second Lien Trademark Security Agreement dated December 27, 2005 (the "Security Agreement"), and recorded with the U.S. Patent and Trademark Office on January 11, 2006 at Reel/Frame No. 3249/0368, the Debtor granted the Agent a security interest in certain collateral pledged by the Debtor described therein, including, without limitation, the United States trademarks set forth on Schedule A attached hereto (collectively, the "Trademark Collateral"); and

WHEREAS, the Debtor has requested that the Agent release its security interest in all right, title and interest of the Agent in and to the Trademark Collateral.

NOW, THEREFORE, the Agent, without recourse, representation or warranty and at the Debtor's sole cost and expense, hereby terminates, cancels and releases the security interest in the Trademark Collateral and any and right, title and interest of the Agent in the Trademark Collateral shall hereby terminate, cease and become void.

Agent agrees to provide Debtor with any information and additional authorization and documentation necessary to effect the release of Agent's security interest in the Trademark Collateral (without recourse, representation or warranty and at Debtor's sole cost and expense).
