CERTIFICATE OF INCORPORATION OF  
DRIVECAM, INC.**

DriveCam, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware,

DOES HEREBY CERTIFY:

**FIRST:** The name of this corporation is DriveCam, Inc. (the "*Corporation*").

**SECOND:** The Corporation's Certificate of Incorporation was originally filed with the Secretary of State of the State of Delaware on September 19, 2008, under the name DriveCam, Inc.

**THIRD:** The Board of Directors of the Corporation adopted a resolution setting forth a proposed amendment of the Fourth Amended and Restated Certificate of Incorporation (the "*Restated Certificate*"), declaring said amendment to be advisable and in the best interests of the Corporation and its stockholders, and authorizing the appropriate officers of the Corporation to solicit the approval of the stockholders therefor, which resolution setting forth the proposed amendment is as follows:

**NOW, THEREFORE, BE IT RESOLVED,** that Article I of the Restated Certificate of the Company be amended and restated in its entirety as set forth below:

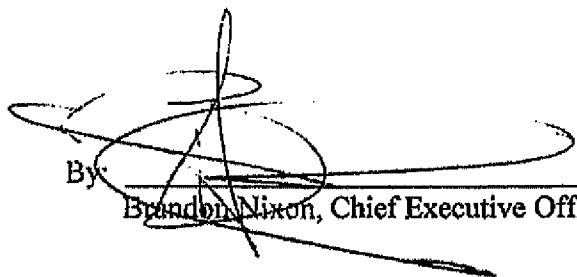
**"ARTICLE I**

The name of the corporation is Lytx, Inc. (the "Corporation")."
