**RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of December 30th, 2013 (this "Release"), is made by General Electric Capital Corporation, as Collateral Agent ("Agent"), in favor of Benchmark Medical, Inc. ("Debtor") as follows:

WITNESSETH

WHEREAS, pursuant to the Trademark Security Agreement, dated December 27, 2005 (the "Security Agreement"), and recorded with the U.S. Patent and Trademark Office on January 10, 2006 at Reel/Frame No. 3248/0443, and the Second Lien Trademark Security Agreement dated December 27, 2005 (the "Security Agreement"), and recorded with the U.S. Patent and Trademark Office on January 11, 2006 at Reel/Frame No. 3248/0388, the Debtor granted the Agent a security interest in certain collateral pledged by the Debtor described therein, including, without limitation, the United States trademarks set forth on Schedule A attached hereto (collectively, the "Trademark Collateral");

WHEREAS, the Debtor has requested that the Agent release its security interest in all right, title and interest of the Agent in and to the Trademark Collateral.


